- **348. - ii) Grant for Village Hall Management Committee A grant application requesting replacement guttering and fascia boards at the Village Hall was received. This was discussed. It was agreed, unanimously, with no abstentions, that provided the Council's financial regulations were met, requiring the Council to obtain three written quotations, and subject to decisions made at the forthcoming EGM, the Council will purchase the guttering and fascias and gift the same to the VHMC.
