In addition: Over development of the site - whilst the site is substantial an additional 4 dwellings is too many Access/Highways - the site is on a bend close to a busy junction with Sandy Lane, which is the site of the local school and opposite a bus stop. Woolsbridge Road also has a new cycle lane. The proposal will result in additional vehicles accessing Woolsbridge Road on this bend. Overlooking - a lot of screening has already been removed and the Council is concerned over possible overlooking particularly as regards the semidetached properties Lack of onsite parking - With 5 dwellings on this site with an allowance of 1.5 cars per dwelling this will lead to parking on Woolsbridge Road and the concerns raised in access should be noted. Concern over turning areas Service and emergency vehicles will not be able to access the site. The proposal is out of keeping and of too high density for the site.
