Proposal substantially increases the footprint. Concerned that this will set a precedent. We would support a sympathetic application to extend, retain, repair or restore this traditional Victorian building in accordance with the LDP Chptr 6 p80. 6.146. We see the loss of this Victorian property as architectural vandalism, these properties define the character of this particular part of the Parish. If the Officer's recommendation is at variance we request that these comments are reported to Committee.
