12/0383	52 Woolsbridge Road, St Leonards- Erect two houses (demolish existing dwelling) and construct access	Strongly object – Serious overdevelopment of this site. Concerned about increase in flooding risk due to increase in hardstanding. Dangerous access directly opposite Lions Wood. Due to lack of on site parking and design of garages concerned that this will lead to reversing across cycle lane and into Woolsbridge Road. Proposal is un-neighbourly to adjacent properties and will impinge on the amenity space of number 50 and others. Not in keeping and the proposal will dominate the street scene. Concerned about loss of screening, light and shadowing of neighbouring

		properties. If Officer is at variance we ask that this goes to EDDC Committee.
