12/0855	Silver Birches Horton Road, Ashley Heath-Extension to form 6 rooms with enSuites for companions and 2 bed unit of accommodation for co-workers. The Proposal includes 2 bedrooms and shower rooms at first floor level and the demolition of the existing garage	Object – The Parish Council has concerns over the scale of the proposal and the additional traffic which the resultant proposal will generate. The existing access lane is unsuitable for additional traffic as it is a rough track and too narrow. There is a lack of onsite parking provision for the additional accommodation and additional staff. We have concerns over the adverse impact on the immediate local residents who have to share this access road. We question whether this property was in the adopted Statement of Development Intent. If the Officer is at variance we ask that this goes to EDDC Committee.

Wessex Water and EDDC have reached an agreement to resolve the situation. The Clerk reported that she had been requested to erect a notice in Jubilee Copse asking residents not to leave out food as this was exacerbating the problem. Cllr Mrs Warman will report this to the EDDC Officer. Cllr Hockley reported a rat problem in the Craigside Road area.
