**Residents Concerns over  
Forestry Proposal**

The Forestry Commission's  
proposal is to clear an area of  
trees covering 6.3 hectares  
(15.5 acres) in the Ashley  
Heath Forest 800 metres from  
the residential housing in  
Ashley Park. This is for the  
purpose of creating an open  
space for recreational events.

The anticipation is that the site  
may be used for up to six days  
per year with two of these  
used to host two open-air con-  
certs on consecutive evenings  
(Saturday and Sunday) one  
weekend a year in summer.  
The concerts will be for around  
5,000 to 7,000 people and the  
site will have the capacity to  
park 2,000 cars to include  
coaches.

The Forestry Commission  
state that they have been  
hosting concerts in seven  
other locations throughout  
England within similar sites  
since 1997.

The Forestry Commission are  
making reassurances that  
noise levels will be controlled  
by use of the latest digital  
sound equipment, vehicle ac-  
cess and egress will be man-  
aged, no permanent structures  
will be erected, no overnight  
camping will be allowed, the  
concert area will be temporar-  
ily fenced for events and car  
parks and access routes will  
be cleared of litter the next  
day.

The Parish Council has re-  
ceived a constant flow of visits  
to the Parish Office, emails,  
correspondence and tele-  
phone calls from unhappy  
residents. This proposal is,  
however, only subject to en-  
tertainment licensing approval  
under which the Parish Coun-  
cil is classed as a non-  
Statutory Consultee.

To facilitate a means of com-  
munication with the Forestry  
Commission, your Parish  
Council arranged an Extraor-  
dinary General Meeting on  
Friday February 29<sup>th</sup> with Mr.

Bruce Rothnie from the Forestry Commission in attendance.

Some 300 residents and the BBC attended the meeting. It was very clear from the beginning that residents were against the proposal and when the question was asked as to who was for the proposal there was only a show of 2 hands.

Questions and concerns expressed were in the main surrounding the following:

- **Environment**- cutting down trees with no replacement. Keeping the area free from litter not only in the concert arena area but also on entrance roads from queuing cars.
- **Potential Fire Hazard** - illegal camping and possible use of barbecues.
- **Noise** - Sound levels required to entertain audiences of 5,000/7,000 with loss of decibels over 800 metres being minimal.
- **Safety** – The Verwood Road (**B3081**) has already been subject to 7 deaths
- **Congestion** – Concerts taking place during summer months with some 2000/3000 vehicles travelling to site accessing and egressing would exacerbate traffic that is already at its heaviest in these months on the A31, A338 and Horton roads.
- **Nuisance Parking** - With queues to access and egress there is a likelihood of parking in side roads and the taking of short cuts in via the many entrances into the area.
- **Security** - The site has numerous access points how can all of these be policed? With a cleared site and access available what is going to stop travellers setting up camp

- **Control of behaviour** – Who will cover the cost of any possible damage to residents' property particularly those properties backing onto the Castleman Trailway and who will bear the cost of using the Police if required?
- **Number of Concerts:** What is the guarantee that it will remain as only 2 concerts over one weekend per year when the Forestry Website already shows a number well in excess of this over the number of sites available.

There was, however, one resident who spoke-up in favour of the project, pointing out that revenue was required to support some already excellent facilities and to sustain the maintenance of the Forestry in general and that there was a need to keep some perspective with regard to the proposal.

Mr. Bruce Rothnie of the Forestry Commission listened to the views expressed by residents and answered a number of the questions.

At the close of the meeting residents requested the support of the Parish Council and their attendance at the licensing hearing when called for. This was put as a resolution before Parish Councillors present and the vote in favour was unanimous.

### **WLTM. Would Like To Mulch**

A keen gardener has contacted the Council to ask if there is anyone in our Parish with land that could be rented as an allotment. A garden, which has become too much for the present owner might fit the bill. Free veg in lieu of rental could be an option. Anything would be considered

### **Cedar Avenue to A31 Footpath**

Following the refurbishment of the Abbey Rose Nursing Home at the end of Cedar Avenue the Council has received several complaints from local residents about the demise of the footpath, which led through alongside the driveway of the home down to the A31. This footpath was not on the definitive map. It is apparent from the information supplied and maps found in archives that a number of residents had used this path for quite a number of years. We now have a number of requests to arrange for the formal adoption of this path. If successful this adoption will protect it for generations to come. For this to happen there is a fairly lengthy procedure to follow.

The first step is to collate evidence forms. Users with 20 years minimum residency need to complete an official witness form. The owners of the land in question have to be notified and provided all the formalities can be completed the County Council will proceed with the adoption. It should be noted that there is more than one owner affected by the proposal.

The Clerk of the Council has spoken to the Manager of Abbey Rose who has suggested that responsible legitimate walkers are welcome to utilise the tarmac driveway down to the A31 although the actual path has vanished in the refurbishment.

Since the publication of our Parish Plan in June 2007, we have been actively seeking to deal with your concerns raised during our Parish Plan consultations and recorded in our Action Plans.

We are represented on East Dorset Community Partnership's Themed Action Groups for Housing, Transport and Environment, and we are finding that other districts within East Dorset share our concerns and problems. However, we would welcome your support and news of specific problems arising from issues including:

1. The dangers of the Woolsbridge Roundabout and wide loads using Horton Road.
2. Insufficient road sweeping, particularly in the Autumn and Winter when the need is greatest.
3. Any problems with fly tipping, dog fouling or drainage.

Whilst the building is owned by the Parish Council the committee is expected to manage the day to day running, maintenance and repairs. ### Endangered Species And Carbon Footprint

Post Offices are at the very heart of local retailing, bringing products and customers together and helping to create sustainable communities. A customer using a local Post Office and Shop leaves a far smaller carbon footprint than someone driving 10 miles to a Superstore.

The National Federation of Sub-Postmasters believes that the UK Government must support the creation of a British Postbank, with a full range of Banking and Financial services products. Our counterparts in Italy, France and Germany all have successful Postbank models.

Within the last four years the Post Office has sold more than 500,000 car insurance policies and over 12,000 van insurance policies in less than a year, putting it en route to taking the largest market share in the field.

A combination of competitive rates, the Post Offices status as one of the largest retail

networks in Europe and being one of the UK's most trusted brands, has been a large factor in these successes.

As to the reduction of the network, there should be a presumption against closing a Post Office where this is the last shop in the village or in a deprived urban area. Despite this, Ibsley Post Office and Stores closed recently. Where next?
